Sub:- Admissible allowances to Public Prosecutors of NR.

Ref:- NR's letter No. 2021/Prose/HQ/RP(UP)Act/PP's Case List/Meeting dated 18.10.2021.

In context of Northern Railways' letter under reference seeking clarification as to whether the Ration Money Allowance (RMA), Washing Allowance and cash compensation in lieu of holidays etc. is payable to Public Prosecutors and Assistant Public Prosecutors and if so, then upto which date; it is stated that the matter has been examined in Board's Office and it is clarified as under:

- (i) Payment of Ration Money Allowance (RMA) to Public Prosecutors (PPs) and Assistant Public Prosecutors (APPs) is to be regulated in terms of Board's instructions issued vide letter No. E(P&A)I-2022/ALL/RPF-1 dated 11.07.2022 (RBE No. 78/2022).
  - (ii) As regards cash compensation in lieu of holidays, it is admissible to RPF/RPSF personnel only as it is paid for each day the RPF/ RPSF personnel actually work on holidays for which it is not possible to grant a compensatory off. It would, therefore, not be admissible to PPs/ APPs as they are now incumbents of the newly formed Prosecutors Cadre and are no longer a part of RPF/ RPSF cadre. But, since the Prosecutors cadre has been created w.e.f.12.06.2019, cash compensation in lieu of holidays would be admissible to PPs/ APPs till 11.06.2019 i.e. upto the day immediately preceding the date of formation of the separate Prosecutors cadre subject to fulfillment of all other attendant conditions.
  - (iii) As regards Washing Allowance, it is stated that the same was admissible to non-gazetted RPF/ RPSF personnel upto 30.06.2017 after which it has been subsumed into Dress Allowance. Since, PPs/APPs were previously part of RPF/RPSF, they are eligible for the payment of Washing Allowance upto 30.06.2017.
2. NR may take further action in the matter accordingly.
  3. This issues with the approval of Associate Finance.


