



Branches of AIRF's Affiliates over Indian Railways.


General Secretary/AIRF has sent a letter through e-mail on date at 13.20 hrs. conveying observance of one day hunger strike by all the Branches of AIRF's Affiliates across the length and breadth of Indian Railways on 12.10.2022 in support of their following demands:-

1. Save Railways from the Privatization and Corporatization.
2. Restore Old Guarantee Pension Scheme in place of NPS for all the Railway Employees appointed on or after 01.01.2004.
3. Provide proper advancement prospects to highly educated youngsters appointed in the lowest level and upgrade at least 30% posts of Level-1 to Level-2 as agreed upon.
4. Resolve pending demands of the Running and other staff of the Safety Categories in a time bound manner.
5. Fill-up all the vacant posts lying vacant, particularly in the Safety Categories within a specified period of time in the larger interest of safe rail operation as well as safety of the existing workforce and stop arbitrary action of surrendering of the posts.
6. Complete the process of the Cadre Restructuring in a timeframe manner and implement the same at an early date.
7. Improve working conditions and promotional avenues of Track Maintainers, S&T and other Technical Staff.
8. Resolve other pending prominent demands of the Railwaymen within a time bound manner.

2. In view of aforesaid, there should not be any room for complacency on the part of the Railway Administration and all necessary steps must be taken to ensure discipline and smooth running of trains. It must be ensured that Railway servants need to seek necessary permission as per extant instructions and provisions and also to leave their headquarters. Instructions may be issued not to sanction any kind of leave including Casual Leave, if applied for participation in the above proposed Hunger Strike.
