Recruitment of sportspersons in the erstwhile Group 'D' quota allotted in Grade Pay Rs. 1800/- (as per 6th CPC) was frozen for the year 2016-17 vide this office's letter no. 2015/E(Sports)/4(1)/11 dated 25.05.2016 and the freeze was continued in subsequent years.

2. The matter has been reviewed and Ministry of Railways (Railway Board) have decided to restart the recruitment in Pay Level-1 (in GP Rs. 1800/- as per 6th CPC) against the sports quota berths allotted to Railways & Production Units (Erstwhile Group D Category) with following revision in sports norms as contained in Board's letter referred (i) above and clarification /corrigendum issued thereto :



2.1 In Badminton, Table Tennis and Tennis : The revised sports norms for recruitment of sportspersons on the basis of their current Annual All India Rankings in Pay Level -1 (Grade Pay Rs. 1800/-) will be as under :

Only the current Annual All India Ranking shall be considered for these purposes. For the purpose of recruitment the highest ranking may be considered valid for one year. Ranking in Mixed doubles shall be considered only in Badminton & not in Tennis & Table Tennis.				

3. All other eligibility norms for recruitment in Pay Level-1 will be same as per existing eligibility norms for recruitment against sports quota in Grade Pay Rs. 1800/-.


