## Appeal against the decision of Divisional Medical Board/Committee against CEN-RRC 01/2019 for the post in Level-I

After Document Verification for the post in Level-I (as per 7th CPC) under CEN-RRC 01/2019, candidates were sent for Medical Examination to Railway Hospitals. Some of the candidates were found unfit for all medical categories whereas some of the Candidates were found fit in lower Medical Categories and they could not be empaneled against CEN-RRC 01/2019 due to non-availability of post as per their relevant Medical fitness status. The list is enclosed herewith.

If these candidates are not satisfied with their above medical fitness report and wish to appeal for their re-medical examination, such candidates can submit their appeal as per provisions contained in Railway Board's Letter No.-2014/HJ5/8(Policy) Dated 07/07/2017 within a period of 30 days from this notice.

The appeal should be sent to Chairman, Railway Recruitment Cell, North Eastern Railway, Gorakhpur and should reach latest by 18.00 hrs. by speed post/person on any working day. No further chance will be given for appeal (a specimen copy of application for appeal is enclosed for reference).

Such an appeal shall be entertained, only if:

- I. The candidate produces a certificate from a Government/Private Doctor of the specialties in which the candidate has been found unfit.
- II. Such certificate should contain a note that the Government/Private specialist is fully aware of the physical & visual standards set by the Railway for the particular medical category, and that he is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate Medical Board comprising of three senior Railway Doctors appointed by the Government in this regard (Certificate should be as per enclosed Proforma "A")
- III. The certificate should bear the photograph and mark of identification of the candidates duly attested by such a Government/Private Doctor, the issuing authority.
- IV. Such an issuing authority shall also clearly mention its MCI/State Registration Number.
- V. Charges will however be payable by candidate and towards this end, a candidate will be required to pay Rs.1000/- (Rupees one thousand only) through Demand Draft payable in favor of **P.F.A, North Eastern Railway, Gorakhpur.**

The decision of PCMD, N.E. Railway, whether the appeal of the candidate should be considered for re-examination or not, will be final and binding on the candidates. Where PCMD is of the opinion that there should be re-examination of the case of appeal, he may nominate a Medical Board to re-examine the candidate. The recommendations of Medical Board duly approved by PCMD will be communicated to the candidate through RRC/Gorakhpur,
