EOI for SALE of In-Service Diesel Locomotives of NORTH EASTERN RAILWAY

1.0 INTRODUCTION

1.1 Background:

- 1.1.1 NORTH EASTERN RAILWAY (NER) has planned for sparing/selling of their diesel locomotive fleet being used for train operations for which NER is asking prospective entities through this to show Expression of Interest. NER proposes to spare/sale 17 Surplus Diesel Locomotive to inland customers through interested prospective entities. The type wise technical parameters of various locomotives, their date of commissioning and their age profile is attached at Annexure-A. Locomotives would be provided in good working conditions duly tested at IR facilities before handing over. The technical documentation of the locomotives would also be provided to help with operation and maintenance.
- 1.1.2 To implement the setting up of the process for sparing/sale of in-Service Diesel Locomotives to inland customers, NER intends to enter into a arrangement with interested entities as per the indicative scope of work given in Annexure B.
- 1.1.3 The various In-service Diesel Locomotives are available at Loco Sheds/ Stations of NER as per Annexure-A and will be spared/sold to the prospective Purchasers. The Diesel Locomotives are generally expected to be utilized in normal conditions.
- 1.1.4 NER shall receive Applications pursuant to this EOI in accordance with the terms set forth herein, as modified, altered, amended and clarified from time to time by NER, and all Applications shall be prepared and submitted in accordance with such terms on or before the date specified in this EOI for submission of Applications.

1.2 Brief Description of EOI Process:

- 1.2.1 The EOI process involves assessments of interested parties/group who make an application in accordance with the provisions of this EOI (the "Applicant"). At the end of this process, NER expects to assess potential Applicants who shall be invited for submission of their financial bids for sale of seventeen (17) In-Service Diesel Locomotives. The applicant is to indicate his interest in purchase of locomotives with at least the following details:
- a. No. of locomotives expected to be purchased
- b. Type wise break up of these expected locomotives
- c. Age group wise break up of these expected locomotives
- d. NER could provide locomotives on broad gauge.
- e. Details, whether locomotives are expected to be used within India or abroad. Information of end customers may be given by applicant, if they choose.

1.2.2 The EOI in two copies (original plus 1) can be submitted duly addressed to following in response to the invitation by hand or sent by Registered Post so as to reach before 16:00 hrs on Sept 13, 2025 at the following address. Alternatively, a signed copy of the EOI may be sent by e-mail as advance copy to be followed by original signed copy which shall be received within 15 days of e-mail.

- 1.2.3 Any request for further information or clarification on the EOI document may be submitted in writing to the Dy. Chief Electrical Engineer/Loco at the above address. NER may respond to the queries raised/clarifications sought to the best of its ability. However, no extension of the time or date of EOI submittal would be granted on the ground that NER has not responded to any query/clarification raised by any party. NER at its discretion may extend the due date for submission of EOI and the decision of NER in this respect would be final and binding on the respondents.
- 1.2.4 It is planned to hold a pre-EOI video conference with potential participants to clarify doubts for better responses on 05.09.2025 at 15.30 hrs. i.e. after a week of publication of invitation for EOI on the website of NER https://ner.indianrailways.gov.in and IREPS. The potential participants are required to forward their respective Emails addresses to the above mentioned E-mail address (ref. Para 1.2.2).
- 1.2.5 No oral modification or interpretation of any provisions of this EOI shall be valid. Written communication shall be issued by NER when changes, clarifications or amendment to the EOI document is deemed necessary by NER at it's sole discretion.
- 1.2.6 EOI submittals should be in English OR HINDI. EOI should be prepared in such a way so as to provide a straight forward, concise description of Applicants capabilities to satisfy the requirements of this EOI. Emphasis should be on (a) conformance to EOI instructions; (b) responsiveness to the EOI requirements; (c) completeness and clarity of content.
- 1.2.7 If at any time during the assessment of EOI, NER requires any clarification on the documents submitted by the prospective parties, it reserves the right to request a clarification so as to complete the assessment.
- 1.2.8 EOI which is found to be incomplete in content and / or attachments and / or authentication etc. is liable to be rejected.

2.0 INSTRUCTION TO APPLICANTS:

- 2.1 Eligibility of Applicants: For determining the eligibility of Applicants for their assessment hereunder, the following shall apply:
- 2.1.1 The Applicant for assessment under the EOI may be (i) a single entity; or (ii) a Group of Entities ("GOE") coming together to meet the scope of the EOI. The GOE shall elect one of their members as the lead member of the GOE. The term Applicant used herein would apply to both a single entity and the GOE.

The lead member of the GOE would be responsible to NER for the entire scope of work and shall ensure back to back tie ups with other members of the GOE.

- 2.1.2 For being considered, A) Details to be provided as per <u>Attachment-I of Annexure-C</u>; and B) Financial Capability: Details to be provided as per <u>Attachment-II of Annexure-C</u>.
- 2.1.3 In case the Applicant is a GOE, it shall comply with the following requirements;
- i) The Application should include a brief description of the roles and responsibilities of individual members of the GOE including that for technical, financial and other obligations.
- ii) An individual Applicant cannot at the same time be member of a GOE applying for assessment. Further, a member of a particular GOE cannot be member of any other GOE applying for assessment.
- 2.2 Right to accept or reject any or all Applications:
- 2.2.1 Not withstanding anything contained in this EOI, NER reserves the right to accept or reject any Application and to annul the EOI Process and reject all Applications, any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof. In the event that NER rejects or annuls all the Applications, it may, at its discretion, invite all eligible applicants to submit fresh Applications.
- 2.2.2 NER reserves the right to disqualify any Applicant during or after completion of EOI process, if it is found there was a material misrepresentation by any such Applicant or the Applicant fails to provide, within the specified time, supplemental information sought by NER.
- 2.2.3 NER reserves the right to verify all statements, information and documents submitted by the Applicant in response to the EOI. Any such verification or lack of such verification by NER shall not relieve the Applicant of his obligations or liabilities hereunder nor will it affect any rights of NER.
- 2.3 Documents to be submitted with EOI:
- i) Letter comprising the Application as per format enclosed at Annexure C along-with information and data required as per Attachments and supporting documents thereof.
- ii) Copy of Articles Memorandum of Association or partnership deed;
- iii) Copies of Applicant's duly audited balance sheets and profit and loss accounts for the preceding year (or all Members in case of a GOE).
- 3.0 Miscellaneous:
- 3.1 The EOI process shall be governed by, and construed in accordance with, the laws of India and the Courts at Gorakhpur shall have exclusive jurisdiction over all disputes arising under, pursuant to and / or in connection with the EOI process.
